The Company would like to update the Exchange that the Kuala Lumpur High Court had earlier fixed the matter for case management on 8 December 2014 pending the outcome of the Motion for Leave to Appeal to the Federal Court filed by the Selangor State Government arising from the decision of the Court of Appeal on 2 April 2014 in allowing SYABAS' appeal to join CIMB Investment Bank Berhad as Co Plaintiff and also to re-amend the statement of claim.

The hearing date on 10 November 2014 has been vacated and a new hearing date has been fixed on 6 January 2015 for the said Motion for Leave to Appeal to the Federal Court filed by the Selangor State Government.
