**Contract Sum** : RM53,400,000.00

**Contract Period** : 21 months

**Completion Period** : 2 September 2015

**Scope of Works** : Supply, jointing and laying of delivery and pumping pipelines, construction and completion of three (3) water reservoirs and three (3) booster stations, supply and installation of mechanical and electrical equipment including testing and commissioning.

**Other Terms** : As privately agreed with the Employer

The Contract is expected to contribute positively to the earnings and net asset per share of Puncak Group for the current financial year ending 31 December 2014.
